Bay Venues is committed to delivering health, wellness and fitness benefits to our community through increased participation in aquatic activities.

We offer Tauranga City Council residents two separate disability access membership types.

1. Disability Access Membership – Caregiver Required

This membership provides access (general swim entry only) to swimmers that have a permanent physical or intellectual disability who requires a caregiver to safely use the aquatic venues. The caregiver must be aged 16+ and must be in or by the water and available to render immediate assistance to the member should this be required. The caregiver cannot also hold a “Disability Access – Caregiver Required” membership. Both the member and the caregiver swim for free under this membership type. A “Disability Access – Caregiver Required” member may not hold any other paying membership with Bay Venues that allows them to utilise our facilities without a caregiver.

2. Disability Access Membership – No Caregiver Required

This membership provides access (general swim entry only) to swimmers that have permanent physical or intellectual disability who do not require a caregiver to safely use the aquatic venues. While having a permanent disability, the member can use the aquatic venues safely without a caregiver present. The member swims for free under this membership type. Please note that normal child supervision rules will still apply.

To be considered for either membership, an application form must be completed, including the section that is required to be completed by a medical practitioner/ disability service.

Please note that any disability access membership not utilised within a 12-month period will expire within our system.

All details and information collected upon application will be treated confidentially and sensitively.
